### About Our Drinking Water...

The Texas Commission on Environmental Quality has assessed our system and determined that our water is safe to drink. The analysis was made by using the data in the attached tables.

The Text of This Report is Dictated by TCEQ Rules and Texas Statute.

The Levels of the Chemical Constituents Detected in the District's Water are Below the TCEQ's Minimum Levels. Nottingham Country MUD has been awarded the "Superior" water rating by the Texas Commission on Environmental Quality.

**Special notice for the ELDERLY, INFANTS, CANCER PATIENTS, people with HIV/AIDS or other immune problems:**



You may be more vulnerable than the general population to certain microbial contaminants, such as Cryptosporidium, in drinking water. Infants, some elderly, or Immuno-compromised persons such as those undergoing chemotherapy for cancer; those who have undergone organ transplants; those who are undergoing treatment with steroids; and people with HIV/AIDS or other immune system disorders can be particularly at risk from infections. #### Where do we get our drinking water?

Our drinking water is obtained from Groundwater sources. It comes from a Gulf Coast Aquifer. The Texas Commission on Environmental Quality will be reviewing all of Texas' drinking water sources. The source water assessment has been completed and upon its receipt from the agency, the report will be available this year. It allows us to focus on our source water protection activities.

#### ALL DRINKING WATER MAY CONTAIN CONTAMINANTS

When drinking water meets federal standards there may not be any health based benefits to purchasing bottled water or point of use devices. Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. Contaminants may be found in drinking water that may cause taste, color, or odor problems. These types of problems are not necessarily causes for health concerns. ## CONTAMINANTS THAT MAY BE PRESENT IN SOURCE WATER

The sources of drinking water (both tap and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

- ◆ *Microbial contaminants*, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife;
- ◆ *Inorganic contaminants*, such as salts and metals, which can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming;
- ◆ *Pesticides and herbicides*, which may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses;
- ◆ *Organic chemical contaminants*, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic systems; and
- ◆ *Radioactive contaminants*, which can be naturally-occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, the U.S. Environmental Protection Agency prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. Federal Food and Drug Administration Agency regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

### DEFINITIONS

<b>AL</b>	Action Level - The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.
<b>MCL</b>	Maximum Contaminant Level - The highest permissible level of a contaminant in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
<b>MCLG</b>	Maximum Contaminant Level Goal - The level of a contaminant in drinking water below which there is no known or expected health risk. MCLGs allow for a margin of safety.
<b>NA</b>	Not applicable.
<b>pCi/L</b>	Picocuries per liter (a measure of radioactivity).
<b>ppm</b>	Parts per million, or milligrams per liter (mg/l).
<b>ppb</b>	Parts per billion, or micrograms per liter (ug/l).
<b>TT</b>	Treatment Technique - A required process intended to reduce the level of a contaminant in drinking water.
